## BRIDGER TOWN COUNCIL MINUTES FOR A REGULAR MEETING HELD ON AUGUST 4, 2020

The August 4, 2020 meeting of the Bridger Town Council was held at 108 South D Street in Bridger. The Pledge of Allegiance was recited, and the meeting was called to order by Mayor Shultz at 7:02 pm. Council members present were Dustin Taylor, Shala Cullum, Mark DeRudder and Doug Asbury. The next item on the agenda was public comment. Gordon Sirrine wanted to thank the volunteers for the Farm to Families program.

Next on the agenda was the approval of the minutes from the July 7, 2020 meeting. Councilman DeRudder motioned to approve the minutes, seconded by Councilman Asbury. The motion carried with the votes as follows: Councilman Taylor – aye, Councilwoman Cullum – aye, Councilman DeRudder – aye and Councilman Asbury – aye.

The next item of business was the approval of claims. The department heads answered questions regarding the claims.
