## BRIDGER TOWN COUNCIL MINUTES FOR JANUARY 6, 2015

The January 6, 2015 Meeting of the Bridger Town Council was brought to order by Mayor Scott DeRudder at 7:00 PM. Council members present were George Wilm, Cliff Shultz, Gerry Roth and Randy Novakovich. Others present were: Krystal Zentner, Police Chief Mike Buechler, Tim Goldsberry Public Works Director and Deanna Hay Town Clerk.

George Wilm moved to approve the minutes as read. Randy Novakovich seconded and the vote was George W-yes, Cliff S-yes, Gerry R-yes, and Randy N-yes. Motion carried.

The Claims were the next item on the agenda. Randy Novakovich moved to approve the claims. Cliff Shultz seconded and the vote was George W-yes, Cliff S-yes, Gerry R-yes, and Randy N-yes. Motion carried.

There were no committee reports.

There were no citizen advisory reports.

There was no correspondence.

Under public comment, dog license/kennel fees were asked to be on the February 2015 agenda.

Mayor Scott DeRudder conducted the 2<sup>nd</sup> Reading of Ordinance #29 amending the residential and business water charges to \$33.23/month. Separate apartment buildings will be \$33.23/month. Apartment buildings with a business floor and multiple apartment floors will be \$33.23 per floor. Out-of-Town resident water is \$33.23+12% (\$37.22) per month. Extra premise water will be \$26.79 per month. Cliff Shultz moved to approve Ordinance #29. George Wilm seconded and the vote was George W-yes, Cliff S-yes, Gerry R-yes, and Randy N-yes. Motion carried. A copy of the Ordinance will be mailed in February with the bills.

Zoning applications were the next agenda item. A zoning application for Eugene Sticka at 501 E Carbon Ave. for an enclosure of an existing car port for an approximate cost of \$1500 was read. Randy Novakovich moved to approve the zoning application. Cliff Shultz seconded and the vote was George W-yes, Cliff S-yes, Gerry R-yes, and Randy N-yes. Motion carried.

Town Attorney Hope Freeman was not present.

Deanna Hay, Town Clerk had nothing to report.

Chief Mike Buechler reported for the year. There are 2 attending Reserve School.

Tim Goldsberry asked the Council about obtaining a backhoe. The Council thought Tim Goldsberry ought to check out the backhoe at Stateline Construction. Also Tim Goldsberry has encountered a problem with the easement to the Town's dump ground. The Council decided that the Town Attorney ought to write something up to make the easement official.

Mayor Scott DeRudder wondered if the Bridger Area Park and Recreation Committee hired someone for snow removal at the skating rink. They have hired someone.

There being no further business Gerry Roth moved to adjourn at 7:38 PM. Cliff Shultz seconded.
